Also, the Applicant will be required to provide the electric utility with a copy of the Approved Final Plan (showing the location of streetlights, if required). The electric utility will not proceed with engineering until the final approved plan is received.

Notification Requirements: The Applicant submitting a Preliminary Plan shall be required to notify the abutting property owners that a plan has been proposed for a specific piece of property. Such notification shall be in accordance with Section §172-12.A of the Subdivision & Land Development Chapter (SALDO). Evidence of such notification in the form of a certified mail receipt shall be presented to the Planning Commission at their first meeting following the formal submission of the plan. Also, the Applicant shall be required to post the property proposed for subdivision and/or land development in accordance with Section §172-12.A of the SALDO **(14 days prior to the Planning Commission Meeting)** The applicant shall notify the Township when the property has been posted. **THE TOWNSHIP PLANNING COMMISSION WILL TAKE NO ACTION ON THE PLAN UNTIL PROOF OF NOTIFICATION AND POSTING HAS BEEN SUBMITTED.**
